- Spring Fling has 5 festival stages. There are also opportunities for street performers.
- Spring Fling primarily books **local and regional acts**.
- Sound, lights, and staging is provided by a professional production company including a sound engineer/mixer.
- Groups will be asked to perform one set ranging from 30-90 minutes depending on the act and the need. Exceptions include street and children's performances.
- All entertainment must be suitable for a family audience. Inappropriate language will not be allowed during a performance and may result in removal of artist or discontinued performance.
- No pyrotechnics allowed.
- All entertainers' merchandise to be sold must be first arranged through festival production coordinator.
- While we make every possible effort to provide a comfortable environment for our entertainers, please understand that this is an outdoor festival - there are no dressing rooms and the performance is rain or shine unless weather is deemed unsafe with thunder and lightening.
- All requested fees are subject to negotiation.
- Upon agreement of engagement, you must sign and return a contract, a W-9, and promotional materials by the stated deadline.
- A signed contract will constitute an agreement to follow all rules & regulations of the festival.
- All payments will be in the form of a City of Spartanburg check upon conclusion of performance.
- No deposits are paid to performers. Performer will be paid by City of Spartanburg check after the performance.
- Please note that application and materials submitted become the property of Spring Fling and will not be returned.
